- The options are bit limited with recent events
 - Habitat is not doing any work days, Diaper Bank is only doing Wednesday/Thursday mornings and Food Bank is limiting to 18 and over
 - Still working on dates/times with the Triangle Conservancy and not heard back from Keep Durham Beautiful
 - TORC Triangle Off Road Cyclist group may need help to clean up trails
 - Parents suggested that Hub Farm and SEEDS might be looking for volunteers

7. Town Hall discussion with Tim Velegol

- COVID Climate:
 - The DPS decision that we are going to stay virtual until the end of the semester was well received by the Teachers, but we understand mixed feelings from families and students.
 - Engineering teachers specifically are very happy with how things are going for the 1st semester and how the kids are showing up and getting the work done/participating.
- Ignite Program Questions
 - DPS is trying to get an idea on how many parents/kids are wanting to keep kids virtual no matter what when 2nd semester starts
 - If Plan B (hybrid model) is approved, high schools will continue online in this plan. Elementary/middle would have to be thinned out and possibly use facilities like RHS to achieve recommended social distancing.
 - At this point, Mr. V feels the plan is that we will be online the entire year for RHS to eliminate the transition and combined online/in person.
 - What does this mean to an Engineering Student?
 - Reality is that staff will be limited, and teachers won't be able to do both virtual and in class learning. There is no way to guarantee we can deliver both in person and online and even fund both
 - Further complicated because to teach these PLTW courses, teachers have to be PLTW certified not just online teacher accredited
 - If students do shift to the Ignite Academy, they won't be removed from the Engineering Program. Hopefully missed classes could be doubled up or picked up in a subsequent year.
- Schedule Change rumors have been being heard. This is coming from a push from the school district that EVERYONE observe lunch from 11:45-12:45.
 - Nothing has been 100% decided on this
 - There is some discussion on starting at 8:30am and maintain first/second period the same length and conform with the lunch requirements
 - Or sticking with 9am and end 11:45 am and shaving off minutes in 1st/2nd period classes and keeping 3rd/4th period classes the same
 - Very unusual set of circumstances and we are just going to have roll with some of this.
 This wouldn't go into effect until the 2nd quarter 10/19.
 - There will be a 7pm meeting with Principal Williams-Leathers on October 15 *look out for info on this in the weekly message & PTA emails
- Engineering Program updates
 - National Technical Honor Society is moving forward
 - Students are eligible after they take 3 CTE classes

- The first round of induction will be for the 60 eligible seniors (that should have been inducted in Spring 2020)
- The plan is to have another induction ceremony in Spring 2021 for other students that are eligible and recommended by teacher/staff
- There is nothing a student can do to advocate for this nomination purely teacher nomination and average CTE of 90 and 3.0 overall grade point average.
- If you think your kid should have been nominated be sure you have your kid check their emails!
- Honor Cords/Stoles achievement based on PLTW final exam scores
 - We are facing some challenges on how we are going to apply these requirements this year. The current class of '21 has had 3 possible ways to be evaluated in their courses.
 - Distinction level on PLTW final exams stoles
 - Achievement level on PLTW final exams honor cords
 - PLTW staff has been working on determining how this will play out and are trying to be as fair as possible
 - 13 seniors already qualified for Distinction 20 possible, 70 eligible for honor cords
 - The plan is for all students to be tested in the traditional end of course and CTE classes. The NC final exams won't be done this year for the other classes. Most students will have teacher-made or department-made final exams for at least 1st semester. Plan is that the CTE and Core classes will be administering some kind of exams. The wrinkle is we don't know what those exams will look like.
 - PLTW is giving school systems the option to administer the final exams remotely
 and virtually as long as the school system agrees to purchase a virtual proctoring
 application. Not sure the application is supported on existing chrome books
 - If we don't use PLTW administered exams then we won't be able to submit PLTW courses for college credit
 - Recognition program issues as we move forward
- Senior Interviews have been almost completed 35 or so left before end of October.
- Junior interviews starting some time in December
- Check out all the enrichment programs that we've sent out recently!

8. Open Questions:

- Parents asking about the original plans about possibly opening the building and options to conduct some hands-on activities like labs and programs. This was a possibility under Plan B but not an option under plan C which we are currently in. We definitely won't see anything like this until 2nd semester if Plan B is undertaken.
- Mr. V was very positive and excited about the clubs that have been popping up and the participation. Students are reporting to him that it's been a positive experience.

- Technical Student Association TSA (see September minutes, REPAC paid the fee for all students to be able to participate). 1pm on Fridays
 - It's a global organization that has literally 100's of online competitions in information technology. Mostly related to computer science/cybersecurity type activities.
